

# OFFICIAL RULES FOR ENTERING THE 2023 SNAP POP QUIZ SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Eligibility:** The 2023 Snap Pop Quiz Sweepstakes (the “Sweepstakes”) is open to any person who is employed by a Snap merchant who wants to participate (each, an “Entrant”). Entrants must be 18 years of age or older at the time of entry, be a US resident and have a valid email address. Persons who are employees of either Snap Finance or its parent, sister companies, subsidiaries, or other affiliates (collectively the “Contest Entities”), or members of the immediate family or someone living in the household of an employee of a Contest Entity (whether legally related or not) are not eligible to be an Entrant. “Immediate family” means parents, spouse, children, siblings, parents, stepparents, stepchildren, and step siblings and their respective spouses, regardless of where they reside. The Sweepstakes is subject to all applicable federal, state, and local laws and is void where prohibited by law and outside the United States. **Timing:** This Sweepstakes starts Friday, September 15, 2023, at 12:00:01 AM Mountain Standard (“MST”) and ends at 11:59:59 PM MST on Sunday, October 15, 2023 (the “Promotion Period”). Snap’s computer is the official time-keeping device for the Sweepstakes.

**How to Enter:** Entrants are entered by answering the quiz and the contact information questionnaire during the Promotion Period. All submissions will be audited daily to remove any submission that Snap deems to be fraudulent or in violation of the Official Rules. All potential winners are subject to verification before any prize will be awarded.

**Limit:** Only One entry per Entrant is permitted. Additional entries will be disqualified. Any attempt by any Entrant to use multiple identities, registrations, logins, or other methods to artificially increase the number of submissions will void Entrant’s entries and that Entrant may be disqualified.

**Grand Prize Drawing:** Snap will randomly select one Sweepstakes winner from the eligible entries received as of 11:59:59 PM MST during the Promotion Period for the prizes as described below.

**Amazon Gift Card Prizes:** There are 3 (three) gift codes entitling 3 (three) winners to obtain a virtual Amazon Gift Card in the amount of \$50, 10 (ten) gift codes entitling 10 (ten) winners to obtain a virtual Amazon Gift Card in the amount of \$25, and 1 (one) gift code entitling 1 (one) Grand Prize winner to obtain a virtual Amazon Gift Card in the amount of \$250. Prizes are not transferable, and no substitution will be made. Snap reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Only entrants with all correct answers to the quiz will be eligible to enter the Grand Prize drawing. Other prizes are limited to one prize per Entrant.

**Prize Drawing:** On or about October 25, 2023, Snap will randomly select one winner per prize according to the following:

- One Grand Prize winner from entries with all correct answers to the quiz as of 11:59:59 PM MST on Sunday, October 15, 2023.
- One winner per each prize: Entrants must have submitted or be deemed to have submitted a filled contact information form to be entered into the drawing.

**General Requirements to Receive any Prize:** The potential winners of any prize will be notified by email, mail, or phone, as determined by Snap. **To be eligible to receive a prize, the potential winner will be required to provide Snap an email address and signed Certificate of Eligibility in applicable form attached to these Official Rules. Except where prohibited by law, I hereby grant the Sponsor, throughout the universe and in perpetuity, the right to use and publish my name, voice, likeness, photograph, biographical and Prize information by any and all means, devices, processes and technology, and in all media, now known or hereafter invented, contemplated or devised, including, without limitation, the internet, television, film, video cassettes, video discs and



other audio-video devices, and radio broadcast and print publications for advertising, promotional and/or other purposes related to the Promotion without notice to me and without further compensation. I hereby acknowledge and agree that I reserve no rights with respect to such uses and that any and all of the rights granted to the Sponsor are freely assignable by the Sponsor.
